GENERAL RENTING TERMS

Pitch renting

1. The renting charges (deposit + charges for file) should be paid from the receipt of the renting agreement and enclosed with the copy to send back.. The deposit will be deducted from the invoice. The total amount of the stay should be paid the day before departure when the reception is open.
2. You should inform us in case of delay as regards the expected date of arrival; with no message, the pitch becomes vacant 24 hours after the date of arrival mentioned in the agreement and the total payment of services can be required.
3. The pitch will be available from 12.00 on the day of arrival and have to be let before 12.00 on the day of departure.

Renting of mobile-homes.

1. Any renting is personal and can't be assigned in any case.
2. The renting charges (deposit + charges for file) should be paid from the receipt of the renting agreement and enclosed with the copy to send back. The deposit will be deducted from the invoice. The total amount of the stay should be entirely paid on the day of arrival. No discount will be made in case of late arrival or early departure.
3. You should inform us in case of delay as regards the expected date of arrival; with no message, the pitch becomes vacant 24 hours after the date of arrival mentioned in the agreement and the total payment of services can be required.
4. In case of cancellation, we will keep or you will pay the reservation charges and the deposit if you cancel more than 15 days before the expected date of your arrival and the total amount of your stay if you cancel less than 15 days before the expected date of your arrival..
5. The mobile-home can be inhabited from 4.00 P.M on the day of your arrival and shall be let before 10.00 A.M on the day of your departure.
Week-end set price : arrival on Friday from 4.00 P.M and departure till Sunday evening 6.00 P.M.
6. Lodgings are let out for a number of persons written on the current price-list and for one vehicle. No exceeding number could be considered without the authorization of the management.
7. Lodgings will be let in the same clean condition as the arrival one. Any damage as regards the lodging or its equipment will induce an immediate reconditioning at the expense of the tenant. The list of items at the end of the stay will have to be strictly the same as the one established at the beginning of the stay, any missing item will have to be paid by the tenant.
8. As a guarantee, the tenant will be required a 200 € security deposit on the day of arrival with two cheques :
 - A 50 € one for the possible cleaning charges at the end of the stay if the mobile- home is not let in the same clean condition as the arrival one. This cheque is given back at the end of the stay.
 - A 150 € one for the possible damages, given back at the end of the stay after possible deduction for repairing or missing items changing. This deposit doesn't limit liability. In case of departure when the reception is closed, the deposit will be sent
 - back to the tenant once the inventory of fixtures done.
9. The tenant must have a liability insurance.
